

# Moratorium Request to Legislature:



## Members of the Texas Legislature Groundwater Moratorium Request

On behalf of the people of Texas, and in recognition that the State is undergoing a crisis in groundwater use that threatens the livelihoods and health of all Texans, we urge the 82nd Texas Legislature to:

- 1. Invoke a moratorium on large groundwater projects, and wholly and comprehensively revise the Texas Water Code, and other laws pertaining to groundwater use and protection.
- 2. Urge the Governor to call a special session of the 82nd Legislature for such purposes.
- 3. Hold public hearings in order to have a full and informed discussion with the public.

#### Statement of Facts:

- State agencies are implementing strategies that assume there is sufficient water for unprecedented growth. In so doing, they are pitting urban against agricultural needs, when in fact, both sectors are reliant upon each other for a healthy economy and people.
- Texas law has long recognized landowner rights to groundwater, except as those rights may be limited or altered by rules promulgated by a groundwater conservation district.
- Discrepancies in statutory and case law leave the status of groundwater ownership, and the relationship of groundwater to surface water poorly defined.
- Private profiteers are exploiting these discrepancies, threatening the economic health of entire regions of the State.
- Texas towns and cities practice inadequate conservation, wasting as much as 30% due to leaky pipes, and 40% in summer for watering lawns. Some sectors of the agricultural industry do not use best practices for water use and conservation.
- Flawed water planning has caused conflicts throughout the State that have not been resolved as required by law.
- Most groundwater conservation districts have permitted wells in violation of the Texas Water Code, with the complicity of the Texas Water Development Board.
- Water rights, groundwater protection and water quality have been undermined by the separate permitting process enjoyed by the oil, gas and mining industries.
- Groundwater contamination caused by natural gas fracturing, aging oil and gas pipelines and mining increasingly threatens our aquifers.
- There is little to no collaboration among stakeholders (rural, urban, agricultural and environmental).
- Land is worthless without water.
- The people of Texas are inadequately informed about the above circumstances.
