

This Landowner Workshop will provide an opportunity for interested landowners to hear updates on the LCRA Transmission Services Corporation's (TSC) application to the Public Utility Commission (PUC) for a 138-kV substation and transmission line. In addition, legal experts will be on hand to discuss landowner rights in the routing and condemnation process. The workshop begins at 9:00 am, with a presentation from LCRA staff. After a short break we will continue with a panel discussion of landowner rights in the transmission line routing process. Legal experts will describe the PUC's criteria for selecting a route, the condemnation process and how landowners can make their voices heard. The program will feature moderated Q&As and will conclude by 12pm.
