House Bill 3405 has voted out of the Senate Committee on Agriculture, Water & Rural Affairs with amendments. Yes, these are amendments we don't like but are working hard to change. Please support Senator Donna Campbell's water bill efforts for Hays County to expand the territory of Barton Springs Edwards Aquifer Conservation District. This local bill will protect property rights and the Trinity Aquifer in Hays County and comes with 6,000 petition signatures and dozens of resolutions of support from city councils, county commissioner's courts, school districts, Pedernales Electric Cooperative, local nonprofits and many neighborhoods. HB3405 passed the House with a commanding vote of 126-15. Both bills have been passed from the Senate Committee on Agriculture, Water & Rural Affairs with amendments. We ask for your support for these senators' efforts on this critical local bill.
