Greg Meszaros | **Director of Austin Water Utility** - Since September of 2007, Greg has been responsible for Austin Water's \$509 million budget, 1,100-plus employees and a \$840 million 5-year Capital Improvement Plan. Greg and his executive team emphasize the achievement of excellence within the organization & have gained key industry recognition for Austin Water. Among these achievements is construction & commissioning of Water Treatment Plant 4 in 2014, one of the largest infrastructure projects in Austin's history. Under Greg's leadership Austin Water has achieved significantly lower peak & average day water use levels, receiving the Peak Performance Gold Award from the National Association of Clean Water Agencies.



John Hofmann | Executive Vice President with the Lower Colorado River Authority (LCRA) - John oversees water, river, irrigation, dam and hydroelectric operations, water surface management, water resource planning, conservation, water quality protection, water customer services and environmental laboratory services. Prior to joining LCRA, John was a regional manager for the Brazos River Authority, where he was responsible for lake and dam operations, water and wastewater treatment and project development. Other career highlights include serving as Gov. Rick Perry's liaison to the Texas House of Representatives and working in the commissioner's office at the Texas Commission on Environmental Quality.
