### PEOPLE:



Judge Sarah Eckhardt, Travis County. Sarah Eckhardt became
Travis County's first female county judge on January 1, 2015. After receiving her
Master of Public Affairs and law degree from the University of Texas at Austin,
Sarah worked for eight years as an Assistant Travis County Attorney. In 2006, she
was elected to represent Precinct 2 on the Commissioners Court. She serves on the
Transportation Policy Board of CAMPO.



**Councilwoman Shirley Gonzales**, City of San Antonio, District 5. In her three terms on the Council, she has championed multi-modal transportation, affordable housing, child abuse reduction, economic development, and a Vision Zero initiative - a citywide program that uses education and smart-street design to help achieve zero traffic fatalities. On her recommendation, the City of San Antonio adopted NACTO guidelines for complete, safe streets into their Unified Development Code.
