**SELL: Wineries can sell wine by the tasting, glass or bottle. We want our Wine Vendors to sell & make a profit!**

The FESTIVAL, hosted by the Hill Country Alliance and a growing list of sponsors, carries a theme of living lightly, responsibly and beautifully in the Texas Hill Country.

Other activities and attractions at this FREE, family-friendly FESTIVAL include 100+ vendors/exhibitors, a full-day's lineup of great speakers, food trailers, tiny homes, tricked-out travel trailers, live music stage — and wine by the taste, glass or bottle from Hill Country wineries!

In 2017, we had more than 1,300 attendees, and we anticipate more this year — coming from urban and rural communities across Central Texas, and other parts of the state too.

**Space - 10x10 area.**

Winery must provide your own tent/tables/chairs/banners/signs etc. Power is available for an additional \$35. Water is not available at the booths, but restrooms are nearby.

Wineries must provide all serving containers, however we hope that the Texas Dept of Agriculture will once again provide up to 1,000 stem-less glasses for our use. You are welcome to bring plastic wine cups or your own branded glasses to use or sell.

**Please use the attached Registration Form and send your check to the Hill Country Alliance to secure your spot.**

A maximum of five wineries will participate on a first-come, first-paid basis. The festival is a covered event and will happen whether rain or shine. There are no refunds after your registration has been accepted and paid.

**TABC Permits:**

Wineries MUST HAVE their own Festival, Farm-to-Market, or temporary permit from TABC. For the TABC permit, you will need a letter from Lynn Dickinson ([LDickinson@cityofdrippingsprings.com](mailto:LDickinson@cityofdrippingsprings.com)), venue manager, to show you are invited to sell wine at the Dripping Springs Ranch Park.

**Setup/Tear Down:**

Vendors can set up on Friday, Oct 19, 1-5pm, or Sat, Oct 20, from 7-9am. Vendors must be in place and ready to sell/serve product to customers by 10 am and remain until 5 pm on the day of the event. No early tear downs please. Take a look at the event floor plan [here](#).
