Compliance and enforcement for community water supplies in the Texas Hill Country

The Texas commission on Environmental Quality (TCEQ) regulates and permits community water supplies and suppliers in the State. TCEQ information about drinking water is available at https://www.tceq.texas.gov/drinkingwater. The U.S. Environmental Enforcement Agency maintains a database of enforcement and compliance history for all facilities regulated by the agency. The site is at https://echo.epa.gov and presents compliance and enforcement data for all facilities regulated by the EPA. The data in the attached Excel-table represent, for the Hill Country area, every community water supply as existed on the EPA website as of September 22, 2018--464 suppliers.

A summary of the compliance and enforcement history for the suppliers is as follows:

- The 464 community suppliers provide the water supply for about 3.85 million people.
- During the last 3 years, 108 of the suppliers had permit violations every quarter.
- During the last 3 years, the average number of quarters with violations is 5.2 (out of 12) per facility.
- During the last 3 years, three facilities had serious violations every quarter.
- During the last 3 years, there were 220 quarters with serious violations--an average of 0.5 per facility.
- 17 of the facilities have current serious violations.
- 27 of the facilities have Health Flags.
- During the last 3 years, 850 rules were violated and 323 are currently begin violated.
- During the last 5 years, there were 5,728 informal actions but only 56 formal actions. Perhaps more formal actions should have been taken.
