In his time as County Commissioner, Shell managed the County's acquisition of a major portion of El Rancho Cima when it came up for sale near Wimberley in his precinct. Commissioner Shell was also the driving force behind formation of the Parks and Open Space Advisory Committee and a public process that eventually saw successful passage of a \$75 million bond for parks and natural areas in Hays County.
